

HAWAI'I CHOCOLATE AND CACAO ASSOCIATION

NEW MEMBERSHIP APPLICATION

There are four (4) categories of Membership in HCCA: Full Members, Certified Members, Associate Members, and Friends. Qualifications and benefits for each category are listed below

Full Membership Qualifications are that you must be a Hawaii business firm (sole proprietorship, partnership, limited liability company or corporation) that sells products containing Hawaii-grown cacao and has been in business in Hawaii for a period of not less than one year prior to the submission of your application. Full Members have voting rights, are eligible to serve on the Board of Directors, are invited to attend HCCA meetings and networking events, receive the Association's newsletter, are eligible for member discounts, have access to the Member area of the HCCA website, and are listed in our membership roster. Dues are \$250 annually

Certified Membership Qualifications are that you must be an individual, sole proprietorship, partnership, limited liability company, corporation, trade organization, university or research organization established in Hawaii that is engaged in the importation or manufacture or distribution of products or services directly related to products containing Hawaii-grown cacao. Certified Members have voting rights, are invited to attend HCCA meetings and networking events, receive the Association's newsletter, are eligible for member discounts, have access to the Member area of the HCCA website, and are listed in our membership roster. Dues are \$150 annually

Associate Membership Qualifications are that you must be an individual, sole proprietorship, partnership, limited liability company, corporation, trade organization, university or research organization that is engaged in the chocolate/cacao industry but has no establishment in Hawaii. Associate Members are invited to attend HCCA meetings and networking events, receive the Association's newsletter, are eligible for member discounts, have access to the Member area of the HCCA website, and are listed in our membership roster. Dues are \$150 annually

Friend of HCCA Any supporter of Hawaii Chocolate is a friend of Hawaii Cacao. Friends are invited to attend HCCA meetings and networking events, receive the Association's newsletter, are eligible for member discounts and are listed in our membership roster. Dues are \$25 annually
